Each individual will be allotted up to three (3) minutes for public comments concerning items of interest within the subject matter jurisdiction of the Public Hearing. Said time frames may be extended only upon approval of the Board.

In addition, the District will arrange for disability-related modifications or accommodations, including auxiliary aids or services, to enable individuals with disabilities to participate in public meetings.
